Clean surface thoroughly with 3837() SEM SOLVE or 38381 WORLD CLASS™ SURFACE CLEANER. Next, sand with 320 grit paper and re-clean with 3837() or 38381.

APPLICATION:

2-3 medium coats Flash time: 5-10 minutes between coats 30 min

NOTE: If clogging develops, remove spray button with a twisting motion and clean with material compliant with VOC regulations in your area. Do not stick pin or other object into can. Gently replace spray button on top of can and spray with button pointed away from you.

NOTE: After each use, turn can upside down and spray several seconds to clear spray tip.

STORAGE: ппг

EZ COAT should be stored in a cool dry place with adequate ventilation away from heat, sparks and flames. The shelf life for EZ COAT is 5 years when stored under normal conditions.
